All tours will be organised exclusively for the 39<sup>th</sup> ICDPPC delegates and their guests by one or more than one designated tour operator(s). However, if the number of the 39<sup>th</sup> ICDPPC delegates and their guests enrolled for a tour does not reach the minimum number of participants of the tour, the tour operator will accept non-39<sup>th</sup> ICDPPC participants to enroll for the tour.
- The tour fees collected by the Conference Secretariat will be paid to designated tour operator(s), the Conference Host and the Conference Secretariat have no interference on the tour prices listed above. Tour fees include one bottle of drinking water, a round-trip transfer and English-speaking guide service throughout the tours, unless otherwise specified. Tentative pick-up points are Kowloon Shangri-La and The Salisbury – YMCA.
- Final tour arrangements are subject to change in weather conditions and minimum quota requirements. In the event of cancellation of tours, the only liability of the Conference Secretariat is to refund the tour fees paid.
